	- Require all workers to wash or clean their hands before entering or leaving the site		
	- Allow plenty of space (two metres) between people waiting to enter site		
	- Regularly clean common contact surfaces in reception, office, access control and delivery areas e.g. scanners, turnstiles, screens, telephone handsets, desks, particularly during peak flow times		
	- Reduce the number of people in attendance at site inductions and consider holding them outdoors wherever possible		
	- Drivers should remain in their vehicles if the load will allow it and must wash or clean their hands before unloading goods and materials

Use alcohol-based hand sanitiser if soap and water is not available and hand washing technique to be adopted as directed by NHS</p> <p>Avoid touching your face/eyes/nose/mouth with unwashed hands and cover your cough or sneeze with a tissue then throw it in the bin.</p> <p>Provide additional hand washing facilities to the usual welfare facilities if a large spread out site or significant numbers of personnel on site Regularly clean the hand washing facilities and check soap and sanitiser levels</p> <p>Provide suitable and sufficient rubbish bins for hand towels with regular removal and disposal.</p> <p>Sites will need extra supplies of soap, hand sanitiser and paper towels and these should be securely stored.</p> <p>Restrict the number of people using toilet facilities at any one time e.g. use a welfare attendant Wash hands before and after using the facilities Enhance the cleaning regimes for toilet facilities particularly door handles, locks and the toilet flush Portable toilets should be avoided wherever possible, but where in use these should be cleaned and emptied more frequently</p>	3 x 1 = 3

It is advised to speak to your H&amp;S competent person on these matters and supplies should be reserved for medical staff as it has been documented that supplies have been difficult to procure</p>	3 x 2 = 6
